SECTION ONE. FINDINGS. The National Council finds that:

A. Currently, there is no provision in the Constitution of the Muscogee (Creek) Nation regarding free press.

B. An independent free press would allow the Muscogee (Creek) citizens to receive unbiased news and reports.

SECTION TWO. PURPOSE. The purpose of this law is to authorize a vote of the Muscogee (Creek) citizens to consider amending the Constitution of the Muscogee (Creek) Nation by adding an Article XIV "Independent Free Press."

SECTION THREE. PROPOSED AMENDMENT. The Principal Chief shall refer to the voters of the Muscogee Creek Nation for their approval or rejection as in the manner prescribed by law, the following proposed Amendment of the Constitution of the Muscogee (Creek) Nation by adding Article XIV Independent Free Press:

ARTICLE XIV – INDEPENDENT FREE PRESS

- 25 Section 1. The Muscogee Creek Nation shall have an Independent Press that shall
- be free from political interest or undue influence, harassment, censorship, control
- 27 or restrictions from any department of the government of the Muscogee (Creek)
- Nation in order to provide unbiased news and reports objectively to the Muscogee

- Section 2. For the purpose of this legislation, Independent Press is meant to include all editorial outlets: Television, Radio and Creative.
